Teaching and learning

Panel Discussion Held

The Department of Tourism and Hospitality Management, St. Mary's University, held a panel discussion on 13 January 2018 at Multi-Purpose Hall, Undergraduate Campus. The major theme of the panel discussion was the Hotel Industry: Operations, Management and Business Trends in Addis Ababa, Ethiopia. and participants were the students of the Department of Tourism and Hospitality Management whose entries are 2008 and 2009 E.C.

The Panelist, Ato Yilkal Bekalu, who has an experience of more than 17 years in the sector, discussed the current performance of hotels in Addis

Ababa (Occupancy Rate and ADR), salesmanship role of Front Office Department, quality service at hotels, employment opportunity, the trends of hotels expansion in Addis Ababa, customer care, hotel facilities management (waste management, water management, etc.), corporate social responsibilities, complaint and emergency handling and his personal experience in dealing with unfortunate situations.

Following the discussion, students raised different questions and suggestions concerning the hotel industry, which made the panel discussion lively.

Tourism Students Visit UNECA

Second year regular students of the Department of Tourism and Hospitality Management, who were taking Hospitality Facilities Management course, paid a visit to the United Nations Economic Commission for Africa (UNECA), Addis Ababa, Ethiopia, on December 21, 2017. The objective of the tour was to integrate the theoretical classroom discussions with practical aspects.



The rationale for choosing the destination was that it is one of the two prestigious conference and meeting venues (one is the African Union) based in Addis Ababa with the-state-of-the-art technologies and stylish architectural design which could be of great interest for tourism students to witness tangible items that supplement the theoretical knowledge they get from the course, Hospitality Facilities Management.

The Conference and Facilities Unit of the UNECA assigned three curators and one security officer for the execution of the entire tour within the premises of the destination. The group which comprised of students, the Department Head, and the course facilitator visited the landscape, the architectural design, and outdoor facilities such as parking lots, green and gardening areas, major conference room facilities and amenities and arrangements within each conference and meeting venues.

The visit to the huge conference halls with their respective seats and amenities, meeting rooms of different sizes, caucus rooms, exhibition spaces, advanced audio-visual equipment, simultaneous interpretation equipment, VIP lounges and ingresses, a well-equipped business center, registration desks, security facilities(such as camera), high-speed wireless internet connections and catering facilities and services helped students relate the theories they discussed in the classroom with the facts on the ground.



During the tour, which lasted for 2 hours, the group had the opportunity to take a close look at each facility and raise questions whenever they needed clarifications and further explanations. The students had the opportunity to sit in one of the two large conference halls and discuss the facilities at the UNECA and deliberate on related issues such as access to the services and facilities of the UNECA, number of conferences and meetings which take place in the premises, rental rates for the conference rooms and other facilities as well as services.

St. Mary's University community celebrated the 12th Nations, Nationalities and Peoples' Day on December 8, 2017 in the premise of the Undergraduate program. The event had two parts. 

Students of MBA in Impact Entrepreneurship Presented Their Business Models

The 1st cohort of the MBA in Impact Entrepreneurship students presented their business models and got feedback on November 19, 2017 after the oneweek Business Modeling and Finance Training was held at the School of Graduate Studies, St. Mary's University (SMU), Addis Ababa, Ethiopia.

The projects presented by the students are diverse in nature, where more than 60% are related to agriculture. While supporting Ethiopia's efforts in food security, these projects are aimed at exporting agricultural products. The remaining projects are on manufacturing, education, sanitation, consultancy and housing.

The student composition is quite diverse in many respects, including age, profession and experience. A significant number of them have already set up businesses and want to scale them up, while others are aspiring to set up new businesses. During the presentations, the students demonistrated passion about their projects, which indicated that they knew what they want to do and were ready to commit themselves toward realizing their dreams. Following their presentations, each student received feedback from judges and their classmates.

> Prior to their presentations, the students were trained on how to design their business models through an intensive session known as Initial Boot Camp which took place from 13-19, November 2017. The trainers were a pool of professors from Ethiopia, Kenya and the USA: Bradley Professor Googins, Professor of Organizational Behavior, Carroll School of Management, Boston College, USA; David Cheboryot, Manager of East Africa Operations, E4Impact, Italy; and Simon Tareke of St. Mary's University. The stu-



dents were provided with tools that helped them develop their business models which will be tested out in the real world whose findings will be reported in the next session.

St. Mary's University conducted a refresher training session on how to guide student research projects to the academic staff of Accounting Department in the Undergraduate Campus. The event took place on 6 January 2018 at the Staff Room of the Department and attended by about 20 staff.

The program was organized by the Department of Accounting and the training was offered by Dr. Kebede Kassa, Director of Research and Knowledge Management Office (RaKMO). It is part of the ongoing effort of RaKMO, in partnership with the various departments, units and programs, to upgrade/refresh skills of staff on different dimensions of research including those conducted by students. The training highlighted, among others, the basics of scientific research, the steps in doing academic research and the need to avoid academic misconduct, including plagiarism. The session revitalized staff interest in research and triggered a lot of pertinent questions, suggestions and recommendations for the future. Some of the key recommendations made by the participants include the need to ensure the continuity of such targeted and tailored training sessions by professional trainers in respective fields. Participants also emphasized the importance of giving such training programs to students, in addition to their course in research methods, right from the first year to their graduation.

Award Ceremony Conducted



The Research and Knowledge Management Office (RaKMO) of St. Mary University recognized best researchers and participants of the University by awarding certificates at a ceremony held on January 4, 2018. The occasion was started by welcoming remarks delivered by Dr. Kebede Kassa, Director of RaKMO followed by an opening speech by Ato Tedla Haile, Executive Vice President of the University. The Executive Vice President emphasized the importance of recognizing best performers as it encourages them to continue doing the same in the future and others to follow their footsteps. He also appreciated the RaKMO for arranging such an event and congratulated recipients of the award.

Then after, Dr. Kebede Kassa reiterated the importance of recognizing staff based on best performance and presented the criteria used to select this year's award recipients. The criteria used to select best researchers mainly focused on active participation in the in-house research activities and participation in knowledge sharing platforms organized by the University. Following this, the Executive Vice President handed out certificates to the selected researchers, namely Dr. Melaku Girma, Professor Tenkir Bonger and Dr. Samuel Dermas. Staffs recognized as best participants included Dr. Elias Nour , Ato Yalew Gorfu and W/ro Mekdes Adane.

Finally, the floor was left open for brief discussions on the way ahead. Accordingly, the audience raised the following issues to be considered in the future:

- 1. The criteria should also consider efforts of authors who publish articles in reputable journals, book chapters and contribution for bulletins etc.
- 2. The number of participants should be large enough since the intention is to encourage others to be best performers in their respective field of work (expanding the audience); and
- 3. RaKMO should strengthen the knowledge management system of the University and ensure proper documentation of activities related to research, publication, and knowledge transfer initiatives.

St. Mary's Took Part in East African Social Enterprises Conference

The Conference, which brought about 300 East African social enterprises together, created a platform where the Ethiopian and Kenyan good practices and challenges were shared.

In his welcoming remarks Mr. Peter Brown, Country Director, British Council - Ethiopia, underscored that social enterprises are key in the social, environmental and economic development of a country. He also mentioned that the British Council is committed to supporting the creation of enabling ecosystem for social enterprises to flourish.

SMU Participation at the GERD Council Meeting

St. Mary's University participated at a meeting organized by the Addis Ababa Great Ethiopian Renaissance Dam(GERD) Council on November 18, 2017, which took place at Ethiopia Hotel here in Addis Ababa. The aim of the meeting was to award and recognize those actively participated in financial support to the construction of the GERD.

The opening remark was made by H.E. Ato Abate Setotaw, Deputy Mayor of Addis Ababa City followed by the presentations of the Council's 2009 E.C. performance report and the 2010 E.C. Annual Plan, by W/ro Shitaye Mohammed, Head of the Addis Ababa GERD Construction Coordination Office. In her 2009 E.C. performance report, she presented the detailed performance of each GERD subcommittee where the Education and Health Committee was rated as very good in community mobilization (planting seedlings, children's Arts Housing of Ethiopia who emphasized the need for social enterprises for Ethiopia's development. Keynote addresses were given by speakers from the UK, Poland and Ethiopia, where each of them aired the practices in their respective countries.

Following the keynote addresses, two panel discussions took place consecutively. The panels allowed Ethiopian and Kenyan social entrepreneurs to share their experiences with participants and the participants raised questions and concerns about the sector. Among the concerns was the lack of clear framework for social enterprises in Ethiopia. In both panels, there were Ethiopian social entrepreneurs, Brukty Tigabu, General Manager, Whiz kids Workshop, Rahel Boon-Gejene, Managing Director/Founder, R & D Group, and Ayatam Simeneh, Executive Director, Beautiful Minds, who shared their experiences.

SMU's Participation at Research Conference

SMU participated at the 11th National Research Conference on University-Industry Linkage, organized by Admas University at Friendship International Hotel, Addis Ababa, on 4th November 2017. According to the organizers, the objective of the event was to create a platform where researchers, the academia, development practitioners, employers and various stakeholders discuss on university-industry linkage in the Ethiopian context. The conference was organized in two sessions where a total of six papers were presented followed by discussion.

The first session was devoted to welcoming and opening speeches and three papers presentation. The welcoming speech was given by Dr. Molla Tsegaye, President of Admas University, followed by the opening speech delivered by Dr. Tesfaye Muhiye, General Director of HERQA.

The opening speech focused mainly on the importance of research and research conferences in higher education towards solving societal problems. It was stated also that Higher Education Institutions (HEIs) should strive to ensure quality of education and need to create strong link and relationship with industries.
